RECIPROCAL DOCK POLICIES AND RATE STRUCTURE

1. ALL BOATS MUST REGISTER WITH THE BYC OFFICE.
2. ALL BOATS MUST FLY THEIR CLUB BURGEE WHILE AT THE BYC DOCK
3. NO PORTION OF THE DOCK SHALL BE RESERVED AS A LOADING ZONE OR FOR RACE COMMITTEE BOATS UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE.
4. RECIPROCAL MOORAGE:
 - a. For reciprocity, visiting yacht club members' club must currently offer reciprocity to the Bellingham Yacht Club.
 - b. Non-group reciprocal visitors will have 1st night free of moorage rate. Additional days' moorage will be the prevailing Port rate.
 - c. A maximum of 3 days per month are permitted unless other arrangements have been made.
 - d. IF NO SPACE IS AVAILABLE ON THE BYC DOCK, BYC WILL REIMBURSE RECIPROCAL CLUB MEMBERS FOR MOORAGE PAID THE PORT OF BELLINGHAM. This is limited to a total accommodation for 140' of reciprocal use of all docks on anyone night. Fill out slip & check "I request reimbursement" box.
 - e. ELECTRICITY FEE IS SEPARATE AND IS \$5.00 PER DAY.
5. GROUP RESERVATIONS:
 - a. For "large" reciprocal groups, the group fee shall be \$125.00 per night after the first day for a maximum 3 day stay. For nonreciprocal groups the fee shall be \$200.00 for a maximum 3 day stay, charged for every day including the first.
 - b. The electricity charge of \$5.00 per day will apply for each individual boat.
 - c. If a BYC member sub lessee is displaced during the group moorage, he/she shall receive the \$5.00 fee charged the group for electricity.
6. SUBLEASES BY BELLINGHAM YACHT CLUB MEMBERS:
 - a. When there is a waiting list for the BYC Dock, the following applies:
 - i. The member does not have other permanent moorage in the Harbor.
 - ii. The member understands that this is not permanent moorage.
 - iii. When the 90 day or sooner occupancy is up, the member will renegotiate the terms of their stay.
 - iv. Sub lessee cannot be "bumped" by a member of greater seniority.
 - v. Priority for sublease shall be by date of BYC membership.
 - vi. No more than 140 feet of dock space will be available for sublease.
 - vii. Cost of moorage is commensurate with current POB rates (40' & 50'), plus a fixed charge of \$250 for electricity per 6 months. POB discounts apply to 6 months payment in advance; or as set by the Board of Trustees of the BYC.
 - viii. A member sub lessee agrees to vacate the dock during the following BYC events: Opening Day, PITCH, One-Design Regatta, Lighted Boat Parade week, and when there is a large reciprocal group that has made prior reservations. If necessary, the BYC agrees to find other moorage for member sub lessee that is temporarily moved.
7. DINGHIES: BYC members may moor their dinghies on the INSIDE of the BYC Dock at a rate of \$1.00 per foot per month. This does not apply to the boats of the Junior Sailors stored in the dinghy rack.
